### 2. PURPOSE OF DISCLOSURE

- Return or destroy all Confidential Information upon written request by the Disclosing Party or upon termination of this Agreement.

### 5. TERM AND TERMINATION

This Agreement shall commence on 16 March 2026 and shall remain in full force and effect for a period of two (2) years, unless earlier terminated by either party upon thirty (30) days' written notice. The confidentiality obligations shall survive termination for an additional period of three (3) years.

### 6. GOVERNING LAW

This Agreement shall be governed by and construed in accordance with applicable law. Any disputes arising out of or in connection with this Agreement shall be subject to the exclusive jurisdiction of the competent courts.
